Introduction

Ten percent of the world's population (nearly one billion people) lived with at least one form of disability in 2011. Moreover, 80 percent of these persons with disabilities (PWDs) lived in developing countries (World Health Organization, 2011). 4.6 percent of Myanmar's population lived with some form of disability in 2014, with more than a quarter of this population with disabilities having multiple disabilities (Department of Population, 2015).

LIRNEasia, in partnership with Myanmar Independent Living Initiative (MILI) and Myanmar ICT Development Organization (MIDO) studied qualitative research to scope out how ICTs were being used by different PWDs, and understand their challenges to more analog components of their lives.

The research questions were as follows:

- What are PWDs' understanding of, expectations for, and experience of, using ICTs?
- How were PWDs using ICTs as assistive technologies, if at all?
- What are the barriers to use for PWDs?

Findings of qualitative and Quantitative research conducted in India were disseminated on 22nd August, 2018 at the Park Royal Hotel, Yangon.

LIRNEasia

LIRNEasia conducts in-depth, policy-relevant research on infrastructure industries including ICT sectors. Their work extends to other sectors such as agriculture and health which can benefit the poorest citizens of the Asia Pacific. MIDO

Myanmar ICT for Development Organization (MIDO) aims to narrow the digital gap in Myanmar, use ICTs as a tool to facilitate development and uplift human rights, and encourage the emergence of good Internet policies for ICT users. Its focus is to help people deploy ICTs as a tool to meet core development goals. As such, the core activities are based on providing seminars and capacity building initiatives on ICT awareness, mainly in rural and suburban areas and on relevant development research around Myanmar's ICT sector.

- to the primary education
- Only 2% of the disabled community would be fortunate to attend to a degree level.
- Even though the government imposed a policy in 2005, still disabled children are acing so many difficulties in education system.
 - Applications rejected for schools
 - No much facilities in practical education same as for the other children
 - Teachers are not fully provided with all the equipment
- She also mentioned the status is better than the past, but still the government (Ministry of social welfare) has to take initiatives to provide facilities and the civil society should be aware of whether all the initiatives are really functioning.
 - ICT facilities to schools
 - Vocational schools for the disabled
- She also invited the business community to allow the PWDs to work, as they are ready to work.
 - Requested to incorporate the disabled access to the buildings, and a fair quota should be allocated for the PWDs.
 - Highlighted that the policy laws are not much supportive for PWDs to work in the business world. The laws should be re-addressed to make firm policies.

Gayani Hurulle

- This is the first research, which was ever carried out in Myanmar.
- With limited resources PWDs were dropped unfortunately from the corporate world
- Policy implementation is very low.
- ICTs use varied by the type of disability, but common mode is mobile phones.
- Some respondents were not able to buy a smart phone even.
- Data packages are not affordable to persons with hearing disability.
- Facebook is most popular social media, and should have paid more attention on FB
- Text to speech accessibility is not available in Myanmar language and lack of Unicode compatible font hindering use by PWDs
 - Zawgyi is the commonly used font in Myanmar. But it is not Unicode compatible, hence not readable by screen readers.
 - Local language text to speech function is not fully workable
- The price for 1GB is low in Myanmar when compared with the other countries in the region. By the meantime GNI is also less, So PWDs cannot affordable Regulators have to fill the gap.
- PWDs are not aware about their rights too.

Zaw Win Naing

- There is a gap between the available policies and the initiatives.
- Government has to take actions to fill the gap together with the community.
- 2.3 million of the population is disabled and it is a huge amount for a country.
- There is no any national committee at the moment.
- Telecom Regulators should provide the best packages instead of the more internet packages for **PWDs**

Sai Kyi Zin Soe

- Role of telecom regulators and operators are critical in these matters.
- USF targeted solutions will do a better service.
- Telecom regulators consider and target economical benefits only.
- They do not work for charity.
- But fair quota should be given to the PWDs with better incentives.
- All the systems should be changed to inclusive systems.
