He was formerly a consultant to the United Nations and also worked as a legislative aide in the Parliament of India, specialising in tax and financial law

address the tax challenges arising from digitalisation of the economy. He is vice chair of Task Force on Digital Economy – a Subsidiary Body of the Inclusive Framework on BEPS.
