Helani Galpaya



Helani Galpaya researches and engages in public discourse on issues related to net neutrality, policy and regulatory bar riers in Internet access, e-Government and broadband quality of service. She also studies and speaks on how knowledge and information disseminated via ICTs can improve inclusiveness of SMMEs (small, medium and micro enterprises) in global agriculture value chains, and how labor is changing due to digitization and entry of digital platforms that reduce transaction costs. She is currently leading

nationally representative surveys of Internet use by households and individuals in India, Pakistan, Bangladesh, Indonesia, Cambodia, Myanmar and Nepal. She is also currently researching how experiences and perceptions of harassment, surveillance and privacy impact the way men and women differentially experience the Internet, and how online identity helps or hinders their digital and political participation

Helani serves on the Board of Editors of the Information Technology and International Development (ITID) journal, is on the Board of Directors of the Global Partnership for Sustainable Development Data (GPSDD), and is a member of the Working Group on Innovation and Commercialisation of the Global Partnership on AI (GPAI), and Club de Madrid's working group on Shared Societies for the 2023 Annual Dialog on Rethinking Social Development for the People and the Planet. She was a member of the Multistakeholder Advisory Group (MAG) of the UN Internet Governance Forum, the Advisory Board of the Harnessing and Sharing Economy for Local Development initiative of the Centre for Implementation of Public Policies promoting Equity and Growth (CIPPEC), Argentina and an Advisor to the UN Broadband Commission's Working Group on Bridging the Gender Divide.

Helani previously worked at the ICT Agency of Sri Lanka implementing the World Bank's e-Sri Lanka initiative. Prior to that she was a management consultant at Booz&Co (formerly Booz Allen Hamilton), New York, and worked at Citibank and Merrill Lynch in New York and Miami. She has an MSc in Technology & Policy from the Massachusetts Institute of Technology, Cambridge, USA and a BA (Cum Laude) in Computer Science from Mount Holyoke College, Massachusetts, USA.

Rohan Samarajiva



Rohan Samarajiva is founding Chair of LIRNEasia, an ICT policy and regulation think tank active across emerging Asia. He was CEO for eight years from its inception in 2004. His most recent co-authored book (2013) is Information lives of the poor: Fighting poverty with technology, published in Burmese, English, French and Spanish. He serves on the Council of the University of Moratuwa, the Board of the Institute of Technology, University of Moratuwa and the National Advisory Council of the Sri Lanka Archives. He serves as Chair of

Sarvodaya Fusion, the ICT unit of Sri Lanka's largest community based organisation and advises Advocata Institute, a Sri Lankan economic policy think tank.

He was Chair of the ICT Agency, the apex body for information and communication technology within the government of Sri Lanka in 2018-19, having been one of its founding directors in 2003-05. He was Team Leader at the Sri Lanka Ministry for Economic Reform, Science and Technology (2002-04) responsible for infrastructure reforms, including participation in the design of the USD 83 million e Sri Lanka Initiative. Samarajiva as Director General of Telecommunications in Sri Lanka (1998-99), Honorary Professor at the University of Moratuwa in Sri Lanka (2003-04), Visiting Professor of Economics of Infrastructures at the Delft University of Technology in the Netherlands (2000-03) and Associate Professor of Communication and Public Policy at the Ohio State University in the US (1987-2000). He served on the Specialty Board in Biomedical Informatics of the Postgraduate Institute of Medicine, University of Colombo (2018-22). He was a member of the UN Global Pulse Advisory Group on the Governance of Data and Artificial Intelligence. He served on its predecessor, the Data Privacy Advisory Group, since 2015.

He received the SLT ZeroOne Lifetime Achievement Award for contribution as a public policy maker and advocate to influence access to cost effective and high quality digital infrastructure in 2018, was recognised as an Internet Pioneer by the Sri Lanka Chapter of the Internet Society in 2015, and was presented with the "Communication Research as an Agent of Change" award by the International Communication Association in 2009. He cofounded the academic journal New Media and Society and serves on the editorial board of Telecommunications Policy.

He was a member of the intergovernmental Joint Study Group on the India-Sri Lanka Comprehensive Economic Partnership Agreement (2003) and chaired the GATS Advisory Committee of the Department of Commerce, Sri Lanka (2002-2004). He was a member of the Board (2003-22) and Chair of the Lanka Software Foundation. Samarajiva chaired the expert workshop on fixed-mobile interconnection for the International Telecommunication Union (ITU) in 2000 and the first Digital Opportunity Forum for the Korea Agency for Digital Opportunity and Promotion (KADO) in 2006.

Pranesh Prakash



Pranesh Prakash is a co-founder of the Centre for Internet and Society, a non-profit that engages in policy research, where he was a policy director till 2018. He's an Affiliated Fellow at the Yale Law School's Information Society Project, and was an India-US Public Interest Technology Fellow at New America in 2019. In 2014 he was selected by Forbes India for its inaugural "30 under 30" list of young achievers, and in 2012 he was nominated as an Internet Freedom Fellow by the U.S. government.

His research interests converge at the intersections of technology, culture, economics, law, and justice. His work has focussed on interrogating, promoting, and engaging with policymakers on the areas of access to knowledge (primarily copyright reform), 'openness' (including open government data, open standards, free/libre/open source software, and open access), freedom of expression, privacy, digital security, net neutrality, and Internet governance.

He is a prominent voice on these issues, with the newspaper Mint calling him "one of the clearest thinkers in this area", and his research having been quoted in the Indian parliament. He regularly speaks at national and international conferences on these topics. He has a degree in arts and law from the National Law School in Bangalore, and while there he helped found the Indian Journal of Law and Technology, and was part of its editorial board for two years.

Semanta Dahal



Semanta Dahal is a practicing Nepali attorney with more than a decade working in Nepal's legal sector. On topics like foreign investment, private equity, project financing, public-private partnerships (PPP), energy and infrastructure, cross-border power trade, and infrastructure concessions, he has provided advice to both Nepali and international clients. He has also participated on discussions with parliamentarians and provided advise to Google, Mastercard and others on topics related data privacy and social media regulations.

Mr. Dahal advised the Office of the Investment Board of Nepal on the drafting, negotiation, and completion of significant infrastructure PPP agreements, including the completion of PDAs for more than 3000 MW projects, each with a value of over \$1 billion. He has also provided government advice on the writing of the PPP laws, the Foreign Investment and Technology Transfer Act, and other investment-related laws in comparable engagements.

Additionally, he provided guidance in the formation and design of the Business Oxygen Private Limited, private equity fund for the IFC and oversaw negotiations for twelve projects totaling more than forty crores Nepali rupees. He recently provided the GON advice over the 500 million USD Compact for Nepal from the Millennium Challenge Corporation (MCC). Semanta studied law at the National Law School of India University and the University of Nottingham with a focus on international economic law. His interests include working with aspiring business owners to offer legal counsel, and as a hobby, he wants to be able to recognize and name all of Nepal's mountain peaks.

Ibrahim Kholilul Rohman is currently Senior Research Associate at Indonesia Financial Group Progress (IFG Progress).
